Jacqueline Rowan made a motion to approve the part-time position for Title IV-D office being paid completely by Prosecutor's Incentive Fund, seconded by William Hartman and all approved.

# MATTER OF LIFE AND SHORT TERM DISABILITY POLICIES and HEALTH PLAN RENEWAL

Andrew Loehr and Alexis Coonan with Gallagher presented their policies: Basic Life insurance to change carriers will result in a \$2,200.00 savings to the County, Long Term Disability Policy for the Sheriff to change carriers would result in a \$3,900.00 savings to the County, Short Term Disability Policy for the Highway to change carriers and offer a better benefit would result in a \$3,850.00 increase to the County. Discussion took place on what policies to offer to certain departments that currently have these polices vs. all County employees. Don Grogg is leaning toward a self-funded

Short Term Policy, and changing companies to result in the savings for the Long Term Policy and Basic Life Policy.

For Health Insurance renewal, Andrew will put us back out to market for pricing. Discussion of possible self-funding of health insurance took place as an option.
