MATTER OF HUMAN RESOURCES

Dotty began by giving an update on insurance renewal and when the meetings are taking place. Next, Dotty discussed the new PUMP Act for nursing mothers. Dotty and the Labor Law Attorney updated the policy in the handbook to meet the requirements of the PUMP Act, and she provided the changes prior to the meeting. The large hospitals in the area offer cardiac scans, Parkview has one for \$50, it is possible for the County to purchase vouchers and the employee would pay \$25 as the employer would pay \$25 and this may be something to add for our wellness around the County. Worker Comp. claims were then discussed. Dotty then went over recruitment around the County.

MATTER OF MAINTENANCE

Larry has reached out to Derek Weimer to get a quote on painting. Larry will get new parts and redo the insides of the toilets to see if that will help. Larry was already locating new faucets for the sinks and plans to change those. Larry will also check into flooring.

Larry also informed the Commissioners that the City of Auburn got new trash bins, and the current ones that are on the courthouse grounds do not fit in them. The City would like to place them in the middle of the ramps with the hopes that the business owners would pull the bins out for trash pickup. Larry does not feel it is a good idea in the middle of ramps for snow removal and other reasons.

Commissioner Watson heard from Mark Olivero and if there is a health emergency for the bat situation then the removal of bats can begin now instead of waiting until August.

MATTER OF KRAFFT SITUATION

Chris Gaumer was in attendance to discuss the newest email sent of the construction of walls and a gate around the debris that needed to be cleared. Attorney Kruse has already sent out a letter to the landowner and the next step would be litigation.

Utility Permit for US 6 Highway Project:

Ben brought in a quote from ARI-HETRA for a quantity of four - 18,000 Lb. capacity 48" – 74" Mobile Support Stands in the amount of \$4,171.12, as well as one- wireless, battery mobile column lift system, 4 columns, 13' forks, min. 109" rim, Adjustable 520mm to 900mm width carriage, 18,000 lbs. per column, 72,000 lbs. total system in the amount of \$50,365.48 and a quantity of 4 pairs of forklift pockets, factory installed on one LP, CB or BPQ MCL in the amount of \$742.32.

Michael Watson made a motion to proceed with the ARI-HETRA quotes for the lifts and stands as detailed out above. Todd Sanderson seconded and all approved.
