ORDINANCE NUMBER 2023-O-5: DCC 16-1-8-1

ORDINANCE FOR 2023 SEA 4 FUNDING

WHEREAS, the State of Indiana under 2023 SEA 4 has established "opt in" funding for local County Health Departments, and

WHEREAS, DeKalb County desires to "opt in" to this funding and use it for the betterment of the health of its citizens, and

WHEREAS, a separate Fund #1161 is required to be established under this law, and

NOW THEREFORE BE IT ORDAINED that DeKalb County "opts in" to the 2023 SEA 4 funding for the local Health Department with the following requirements and process:

- 1. The County Commissioners agree to accept the "opt in" funding for the 2023 SEA 4 and to sign the resolution accepting SEA 4 which is being adopted herewith. This "opt in" is for the year 2024 only.
- 2. The funding from the state under SEA 4 shall be placed into a separately maintained account within Fund 1161 by the Auditor.
- 3. The funding from the state under SEA 4 cannot be spent by the County or its Health Department except after prior approval of a yearly expenditure plan or other separate authorization approved by the County Commissioners.
- 4. The Director of the Health Department shall provide a yearly expenditure plan for the 60% restricted portion of the yearly SEA 4 funding [See Indiana Code Section 16-20-1-12]. SEA 4 itself has various categories of allowed expenditure. The Director of the Health Department shall comply with the required categories in the 60% portion of the SEA 4 spending. Commissioners will then approve, deny, or modify said plan before any actual expenditures are allowed.
- 5. Disbursements from the 60% restricted portion of the funding are not allowed until approved by the Commissioners.
- 6. The 40% portion of the fund shall be spent according to the needs of the Health Department as determined by the Director of the Department Health as part of the normal budget process.
- 7. The SEA 4 funds need to be appropriated by the DeKalb County Council prior to claims being submitted for payment.
