Rick Collins opened the meeting with prayer at 8:33 a.m.

MATTER OF MINUTES

David Yarde made a motion to approve minutes dated November 15, 2023. Amy Prosser seconded and all approved.

MATTER OF HEALTH DEPARTMENT 2024 WAGE DISCUSSION-Kathy Rutledge

Kathy Rutledge came to ask the Council to re-evaluate her position as Clerk/Vital Records Registrar. She feels that last month she failed to explain the liability that she helps take off the Health Department/County. She also feels that her position does not fit in any Classification Category.

Councilman Ring asked if anyone had any questions and verified with the Auditor that this position did in fact get a 6% increase for 2024. Councilman VanWye, as the Health Departments Liaison stated that he feels the position does need an increase, but he does not know how to raise this one position and keep everyone else in check. The council feels the wages need to be looked at but at this time for 2024 the Council has done as much as they can. Councilman VanWye feels that if he were to make a motion it would die for lack of a second and feels this should be looked at the beginning of the year. Councilwoman Prosser asked if this process was customary with the employee coming in an requesting a raise, and that usually it is the department head that does the requesting at budget time. Councilman Ring agrees this is not a customary process. Councilman Ring suggested of possibly engaging with WIS to have them provide the Council the appropriate rates for the category/job descriptions. Councilwoman Prosser asked if WIS looked at the benefit packages along with the job descriptions and expressed how this should be looked at and would be willing to look at quotes from vendors on who/what they can provide. Councilman Ring also feels we need to look at where we are losing people from and use the information at budget time for 2025 budget prep. The Council agrees to have HR get quotes from multiple vendors for this type of work.

MATTER OF ADDITIONAL APPROPRIATIONS

MATTER OF DEKALB COUNTY AIRPORT UPDATE

Council and Commissioner Brief 12/12/2023

New Business

- The changeover from AvGas to JetA thereby expanding our JetA storage from 12,000 gallons to 24,000 gallons is underway. The tank was cleaned out and an epoxy liner was added. Hoosier equipment is currently working on adding a floating suction device along with an equalizer pipe between the tanks. They will also change out the filtration to JetA compatible vessels in the coming weeks. Sweet aviation will take delivery of a new 5,000 gallon JetA truck so our total storage on airport will be 29,000 gallons giving them buying power/timing and insulation again supply chain hiccups, and enough fuel to satisfy significant anticipated growth.
- The 2024 NAVAIDS Relocation Project will begin on January 15th. We will be closed but for 15-minute prior permission through February 28th. This will allow the contractor to install all the MALSR approach lights, the in-pavement lights, and the distance remaining signs. The earthwork portion of the project will start in the spring where we will take dirt from the south side of the current runway and place it southeast of the new runway area to finish the Instrument Landing System (ILS) image forming area. This is simply a very flat area required in front of the ILS antenna. We will also be replacing our airport beacon and the Automated Weather Observation Station later next year.
- > John Brye has briefed us that they now have all the costs associated with moving the church and they are putting together a grant application and organizing the crowd funding process. We have no idea how long this process might take from here.
