APPROVAL OF MINUTES:

JUDGE GRIMM MOVED TO ACCEPT THE MINUTES AS SUBMITTED. SECONDED BY STEVE SMITH. MOTION PASSED.

REPORT OF OFFICERS:

Appointment of a new Chairman for Community Corrections. Judge Kevin Wallace was nominated. Judge Grimm moved to accept the nomination; seconded by Tom Drzewiecki. Motion passed.

OLD BUSINESS:

None

NEW BUSINESS:

A financial summary for both adult and juvenile was available for review.

Offender Placement - Home Detention, 27 adult offenders; 2 of which are CTP; One (1) adult on SCRAM and one (1) adult on Day Reporting. There are three (3) adults on the Non-Support Program and fifteen (15) juveniles attending CHANGE Academy. Also, 125 individuals are on the Community Service Restitution Program.

The DOC estimates it costs approximately \$53.96 per day per individual. Community Corrections supervision since July of 2010 is a total of 77,535 days(MEMS NOT included). Which would cost \$2,713,725.00 in the county jail and 44,183,88.60 at DOC.

CHANGE Academy will not be included in the new Community Corrections building. A letter of opposition was submitted by the Superintendents of the DeKalb County School Districts.

DCCC/CHANGE Academy will work with Probation Prosecuting Attorney and Circuit

Court to create a memorandum of understanding for approval at the next meeting.

Kellie has identified the Maximum Daily Capacities for its current adult levels of supervision. Electronic Monitoring: 60; Day Reporting: 50; Community Service: 150. There are a few other programs that are not in place at this time and no determination was made for these.

Work Release:

Much discussion was had on the new building, the new road, sewers and water. December 18, 2017 at 9:30 A.M. a proposal will be delivered to the DeKalb County Council by Commissioner Don Grogg and he will be calling for a vote on the project.

At the next Advisory Board meeting the Grant will be ready for approval of the Board.
