

Petition No. 15-08 DeKalb County Plan Commissioners

AN ORDINANCE AMENDING THE UNIFIED DEVELOPMENT ORDINANCE OF DEKALB COUNTY, INDIANA WHICH INCLUDES THE ARTICLE 1 THROUGH ARTICLE 12 AS WELL AS SUCH AMENDMENTS BY ZONING ORDINANCES ENACTED AFTER THE 1ST DAY OF JANUARY, 2009AS FOLLOWS:

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF DEKALB, STATE OF INDIANA, THAT THE UNIFIED DEVELOPMENT ORDINANCE OF DEKALB COUNTY, INDIANA BE AMENDED AS FOLLOWS:

## UNIFIED DEVELOPMENT ORDINANCE

Article 2, 2.03; A1, Conservation Agricultural District Intent, Permitted Uses, and Special Exception Uses, add to the Permitted Uses under Agricultural Permitted Uses: "confined feeding operation – up to two (2) times Indiana Department of Environmental Management CAFO numbers." Article 2, 2.05; A2 Agricultural District Intent, Permitted Uses, and Special Exception Uses, add to the Permitted Uses under Agricultural Permitted Uses: "confined feeding operation - up to two (2) times Indiana Department of Environmental Management CAFO numbers." Article 2, 2.07; A3, High Intensity Agricultural District Intent, Permitted Uses, and Special Exception Uses, add to the Permitted Uses under Agricultural Permitted Uses: "confined feeding operation - up to two (2) times Indiana Department of Environmental Management CAFO numbers." Article 2, 2.07; A3, High Intensity Agricultural District Intent, Permitted Uses, and Special Exception Uses, add to the Special Exception Uses under Agricultural Special Exception Uses: "confined feeding operation – above two (2) times Indiana Department of Environmental Management CAFO numbers." Article 2, 2.37; I2, Low-Intensity Industrial District Intent, Permitted Uses, and Special Exception Uses, add to the Permitted Uses under Agricultural Permitted Uses: "CFO". Article 2, 2.39; I3, High-Intensity Industrial District Intent, Permitted Uses, and Special Exception Uses, add to the Permitted Uses under Agricultural Permitted Uses: "CFO".



This ordinance shall take effect on the date of its passage and approval by the Board of County Commissioners.
