Now therefore: the County Commissioners approve the acceptance of the street improvements on the condition that the aforesaid improvements are completed on or before this 1st day of July, 2016.

As a condition of the aforesaid approval the owner deposits herewith an Irrevocable Letter of Credit # 6464 to be forfeited upon owner's failure to complete the improvements outlined above.


