WHEREAS, the DeKalb County Council recognizes the need to stimulate economic growth and to maintain a sound economy within DeKalb County, and

WHEREAS, the DeKalb County Council recognizes the desirability of providing incentives to the development of unused land located within DeKalb County when there has been a cessation of growth and a lack of development, and

WHEREAS, the DeKalb County Council recognizes that it would be beneficial to the county to designate certain areas where development and growth have ceased as Economic Development areas in order to stimulate the use of said property by marking tax abatement available, and

WHERAS, Indiana law, namely, INDIANA CODE 6-1.1-12.1 through INDIANA CODE 6-1.1-12.1-5.7 provides for a method whereby real estate can be designated as an Economic Revitalization Area in order to stimulate development of said area by making tax abatement available.

NOW, THEREFORE, IT IS RESOLVED by the DeKalb County Council as follows::

1. That the following described real; estate shall be designated an Economic Revitalization Area for a period of ten (10) years and any personal property located thereon shall be entitled to deduction as provided in INDIANA CODE 6-1.1-12. 4d(3).

- 2. That THREE DAUGHTERS CORP. d.b.a. RATHBURN TOOL AND MANUFACTURING, shall have a period of two years in which it may purchase new machinery and equipment that would qualify for tax abatement for the period of ten (10) years. Any manufacturing equipment so purchased shall be entitled to the deduction as provided in INDIANA CODE 6-1.1-12.4.
- 3. That THREE DAUGHTERS CORP. d.b.a. RATHBURN TOOL AND MANUFACTURING, shall apply for the deductions provided for herein as specified in INDIANA CODE 6-1.1-12.
