# Ordinance # 2021-OCC-17 An Ordinance Amending the DeKalb County 2021 Salary and Hourly Wage Ordinance

WHEREAS, DeKalb County Council approved its budget for 2021 by passing the 2021 Salary and Hourly Wage Ordinance on September 28, 2020 and,

WHEREAS, the budget established by the County Council did not include salary, hourly and wage for individuals whose salary classification had not been established,

NOW, THEREFORE, be it ORDAINED by the DeKalb County Council that the 2021 Salary and Hourly Wage Ordinance for the 2021 Budget is hereby amended to include the reclassification and that the employee will be paid within the range represented from the Federal Minimum wage to a maximum of the dollar amount set forth on this ordinance, unless amended.
