Ordinance # 2021-OCC-27 An Ordinance <u>Amending</u> the DeKalb County 2022 Salary and Hourly Wage Ordinance DeKalb County Council

The DeKalb County Council hereby establishes the following: Salary and Hourly Wage Ordinance to become effective for pay period 12/19/2021 to 1/1/2022 (paid on 1/14/2022) thru pay period 12/4/2022 to 12/17/2022 (paid on 12/30/2022).

IT IS FURTHER ORDAINED that all salaries and wages shall be paid bi-weekly (26 pays).

IT IS FURTHER ORDAINED that any employee hired after the date of this ordinance will have one pay period withheld for audit purposes.

IT IS FURTHER ORDAINED that compensation of employees and elected officials, may include, but not limited to, if provided and meets eligibility, a stipend, health insurance, Health Savings Account (HAS), professional certifications, educational advancements, and per diems, regardless of the source of funds for which the money is paid.

NOW, THEREFORE, be it ORDAINED by the DeKalb County Council that the Salary and Hourly Wage Ordinance for the 2022 Budget is hereby amended to include the reclassification listed and/or that the employee will be paid within the range represented from the Federal Minimum wage to a maximum of the dollar amount set forth on this ordinance, unless amended.
