ORDINANCE GRANTING THE RECORDER'S REQUEST TO USE MONIES FROM THE RECORDER'S
RECORDS PERPETUATION FUND TO SUPPLEMENT THE RECORDER'S 2021 BUDGET

By the affidavit contemplated by I.C. 36-2-7-10.2 (b), the County Recorder has requested the sum of \$21,500.00 of the Recorder's Perpetuation Fund be used to supplement payment of the Part Time Salary for the 2021 calendar year.

Pursuant to I.C. 36-2-7-10.2 (c), upon receiving the Recorder's Affidavit, the County Council may adopt an ordinance approving the Recorder's request.


The Recorder's affidavit is in proper form and content and the County Council wishes to grant the Recorder's request.


NOW, THEREFORE, IT IS ORDAINED AS FOLLOWS:







AFFIDAVIT

I, Katie Firestone, after first being duly sworn upon my oath, state as follows:

1. I am the duly elected Recorder of DeKalb County, Indiana.
