

Ordinance No. 2016-OCC-7
AN ORDINANCE AMENDING THE DEKALB COUNTY
2016 SALARY ORDINANCE (SALARY& PART TIME)

WHEREAS, DeKalb County Council approved its budget for 2016 by passing the Salary Ordinance and Part Time Pay on October 26, 2015 and,

WHEREAS, the budget established by the County Council did not include salaries for individuals whose salary classification had not been established and,

WHEREAS, the budget established by the County Council for the Part Time Employee Hourly Wages was submitted with salaries for individuals whose salary classifications have changed;

NOW, THEREFORE, be it ORDAINED by the DeKalb County Council as follows:
