

ORDINANCE NUMBER 2015-CC- 2
AN ORDINANCE CORRECTING ORDINANCE NUMBER 2015-CC-1

WHEREAS, the DeKalb County Council passed Ordinance Number 2014-CC-8 providing for DeKalb County General Fund Appropriation of \$10,215,934.00.

WHEREAS, the Department Of Local Government Finance reduced the appropriation to the DeKalb County General Fund by \$740,070.00 to the sum of \$9,475,864.00.

WHEREAS, the DeKalb County Council desires to reduce the appropriation of the County General Fund by an additional \$325,886.00 to \$9,149,978.00.

WHEREAS, DeKalb County Council is required to bring their appropriation in line with the final determination of the Department Of Local Government Finance:






