Reinhart was not only a lifelong farmer in the Butler area, but also found time to serve as a bus driver for DeKalb Eastern School District for twenty plus years; was a four year member of the Northeast Indiana Regional Coordinating Council in Fort Wayne; served on the DeKalb County Fair Association Board of Directors; and also served for over forty years as director of DeKalb County Farm Bureau Co-op Credit Union/DeKalb Financial Credit Union, now a part of Beacon Credit Union; and also was an active member of the DeKalb County Farm Bureau; and

**WHEREAS**, the County and citizens of this County are indebted to John H. Reinhart for his unselfish leadership and service to our community.

**NOW, THEREFORE, BE IT RESOLVED**, that the DeKalb County Commissioners and the DeKalb County Council commemorate the life of John H.
