DEKALB COUNTY CODE SECTION 8-1-2-20

DEKALB COUNTY COMMISSIONERS

AN ORDINANCE CONFIRMING DEKALB COUNTY, INDIANA, BY AND THROUGH ITS BOARD OF COUNTY COMMISSIONERS, THE TRANSFER OF JURISDICTION OF PORTIONS OF COUNTY ROAD 60 BETWEEN STATE ROAD 1 AND WIDNEY STREET TO THE TOWN OF ST. JOE

WHEREAS, DeKalb County and the Town of St. Joe have discussed the fact that a portion of County Road 60 between State Road 1 and Widney Street would better meet the needs of the citizens if it were under the control of the Town of St. Joe; and

WHEREAS, both the Town of St. Joe and DeKalb County, Indiana, believe it is in the best interests of the parties that the road described herein be transferred from DeKalb County, Indiana, to the Town of St. Joe.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE DEKALB COUNTY COMMISSIONERS OF DEKALB COUNTY, INDIANA THAT:

Section 1. The Town of St. Joe has expressed an interest in having County Road 60 between State Road 1 and Widney Street transferred to its jurisdiction and has expressed a willingness to accept said County Road 60 and has agreed to control, govern, and maintain said County Road 60 between State Road 1 and Widney Street.

Section 2. DeKalb County, Indiana, by and through its Board of County Commissioners, agrees with the transfer of said County Road 60 between State Road 1 and Widney Street to the sole care and control, governance, and maintenance to the Town of St. Joe.

Section 3. DeKalb County, Indiana, by and through its Board of County Commissioners hereby transfers County Road 60 between State Road 1 and Widney Street to the municipal Town of St. Joe, effective immediately upon passage of this ordinance and the acceptance by the Town of St. Joe of County Road 60 between State Road 1 and Widney Street, and assumes control, governance, and maintenance of said portion of County Road 60.


READ AND PASSED ON SECOND READING: Monday, October 24<sup>th</sup>, 2022.
