MATTER OF MINUTES:

Janet Ordway made a motion to approve Minutes of April 2, 2012, William VanWye second and all approved.

MATTER OF ADDITIONALS:

Brad Stump of the GIS Department was in with an additional request of \$30,000 for Software Maintenance. Alan Middleton made a motion to "Table" the request until the actual amount that is needed is known and GIS with the Commissioners may use up to \$23,000 until the exact additional is approved, William VanWye second and all approved.

From Cumulative Capital Development (1138): To Jail (0023) \$12,597.00 to fabricate and install (18) new steel bunks. Janet Ordway made a motion to approve, Larry Moughler second and all approved. Also to Jail (0023) \$18,068.53 to purchase replacement lighting, Alan Middleton made a motion to approve, William VanWye second and all approved.

From Cumulative Capital Development (1138) to Jail (0023) \$61,600.00 to replace the roof, the quote is from Albert's Roofing. It was questioned if this quote included a slant on the roof, the sheriff will investigate. Janet Ordway made a motion to "Table" the request, Donna King second and all approved. The Sheriff returned with a statement from Albert's Roofing that a roof of this size does not need a slant. Janet Ordway made a motion to remove the "Tabled" motion and approve the request of \$61,600.00 to replace the Jail roof, William VanWye second and all approved.

MATTER OF DEKALB COUNTY COMMUNITY CORRECTIONS BUDGET:

The director of DeKalb County Community Corrections Kellie Knauer presented their budget for the department which starts July 1, 2012 and ending June 30, 2013.

MATTER OF ADDITIONALS:

The Department of Community Corrections requested an \$8,000 appropriation to be deposited into fund 4922 – Project Income; account 34330 – Professional Contracts from County General (1001) for a Work Release Feasibility Study through Schenkel Shultz Architecture. Donna King made a motion to approve, Janet Ordway second and all approved.

The DeKalb County Central Communications would like to open an Office Supplies account, 1001.22110.000.0034 with \$1.00. Janet Ordway made a motion to approve, William VanWye second and all approved.

Donna King left the Council Meeting at 10:00 AM.

Cumulative Bridge Fund (1135) for Highway Department: Bridge design for replacement of Bridge #31 on CR 9 over Black Creek account #35415 in the amount of \$47,000.00; Replacement of small structure #31 on CR 10 over the J. Hamman Drain account #35420 in the amount of \$45,000.00; Replacement of small structure #202 on CR 31 over the D. Link Drain account #335425 in the amount of \$65,000.00; Replace small structure #307 on CR 68 over Jerry Davis Drain account #35430 in the amount of \$26,000.00; and Replacement of small structure #375 on CR 56 over the Nancy Davis Drain account #35435 in the amount of \$45,000.00. FHWA is requiring all L.P.A.'s to have their sign inventory installed on a GIS database, this is a Federally funded project with 90% being reimbursed. Alan Middleton made a motion to approve, Robert Wilder second and all approved.
