#### MATTER OF HIGHWAY

A motion by Don Kaufman to approve the agreement between DeKalb County and the City of Garrett granting former county street and road jurisdiction to Garrett was seconded by William Ort and carried.

A motion by Don Kaufman to approve and president Ort to sign the LPA Claim for \$12,088.02 to close out the pavement rehabilitation project on County Road 427 which ended in 1997 was seconded by William Ort and carried.

A motion by Don Kaufman to approve and sign the RFP to GAI for Project 0400034 for engineering services on County Roads 427 and 60 was seconded by William Ort and carried.

## MATTER OF SPECIAL CLAIMS

## MATTER OF COURTHOUSE WINDOWS

Following the bid process, color selection must be made for the framing. The commissioners agreed that it might be well to consult county historian John Martin Smith with regard to the color.

## MATTER OF RELAY FOR LIFE

Custodian Clint Stephens and Linda Anderson of the auditor's office requested scheduling to use the courthouse and office building for events to obtain contributions for the Relay for Life event. A breakfast is planned for March 10 in the rotunda, a scrapbook event April 9<sup>th</sup> in the large meeting room in the office building, and a Euchre tournament at the Auburn American Legion on March 19<sup>th</sup>. The Relay for Life is May 21<sup>st</sup> and 22<sup>nd</sup>. The commissioners have no objections to the use of the county facility for the projects.
