#### MATTER OF SUNNY MEADOWS

A motion by Don Kaufman to authorize Howard Richardson to sign for grain and feed subsidies and other agreements pertaining to the Farm Services Program and authorize President Ort to sign the letter of authorization was seconded by Connie Miles and carried.

# MATTER OF SUNNY MEADOWS

There was discussion with regard to changing the guardianship for several residents at Sunny Meadows, since former administrator Janel Snow has resigned. Janel will come to speak to the commissioners later in the day concerning remaining issues. Since tenant farmer David Kimmel has moved from the farmhouse and plans to retire in January, it was decided that Howard Richardson should move into the former superintendent's apartment at Sunny Meadows until such time as the tenant house is renovated or other arrangements are made. This will allow Howard to remain on site to manage any problems with the livestock.

Henry Johnson, a former Sunny Meadows resident who was transferred to Betz Nursing Home has died.

#### MATTER OF SCANNING EQUIPMENT

Jeff Bassett presented a proposal for scanning equipment for the plan commission and clerk's offices. A motion by Don Kaufman to purchase a DC425AS Scanning Accessory for the plan commission office was seconded by Connie Miles and carried. The equipment is very much needed for document storage within the system as there is little space for file cabinets. Newly purchased copiers are now equipped with scanners, and will be most useful in the near future for the surveyor and auditor. The clerk is now scanning documents with a machine purchased at an earlier date, and there was no additional money for a second machine at this time.
