New Business

- ➤ The 2024 NAVAIDS Relocation Project continues to move along. We are again 3-weeks behind due to further FAA changes in scope, and subsequent material delays. We are still fighting to meet FAA flight check and all of the associated deadlines and to have our approaches published October 31st of this year.
- The EAA's Ford Tri-Motor will be on the airport giving rides August 16, 17 and 18.

- > We expect grants for next years projects between now and late September. The Board has already voted to accept them once they arrive so there is no delay and so that we can get the contractors under contract immediately.
- > The committee working on the airport name change wants to meet one more time before they make any decisions public.

MATTER OF 2025 NON-BINDING REVIEWS

According to IC 6-1.1-17-3.6, the County Fiscal Body shall review the estimated levy limits and the distribution of property taxes reduced by credits provided by DLGF for each taxing unit. The County Council must review the information and make its recommendation about the action proposed by the unit. The County Council's recommendation is "non-binding," which means that the unit of government does not have to follow the recommendations. Auditor Sleeper shall distribute a copy of these minutes, once approved to all taxing units.
