MINUTES OF LAST MEETING:

Mayor Yoder made a motion to accept the minutes of last meeting as submitted. Steve Smith seconded. Motion passed.

REPORT OF OFFICERS:

Judge Wallace spoke about the latest Letter to the Editor from Joe Laher. It is believed that there is some misinformation and uninformed people in the area. We need to continue to get the story out about Community Correction. Several ideas were discussed as to how that could happen, perhaps more on Facebook or interview an individual who has gone through the program and has successfully completed it.

NEW BUSINESS:

Kellie reviewed the Financial Summary as of April 30, 2018.

Transfer request was made in order to purchase a Shredder; for Telecommunications and Building Rent and Cameras and Computer equipment update. This would require moving monies from the State grant to the appropriate accounts. Judge Brown moved that this should be done. Seconded by Tom Drzewiecki. Motion passed.

Offender Placement on Community Correction was discussed. There are thirty-two (32) adults on electronically monitored home detention and one (1) on Pre-Trial Veterans Treatment Center compliance. Two (2) adult offenders on SCAM and one hundred twenty-eight (128) adults on Community Service Restitution Program. Three (3) adults on pre-trial compliance; and

four (4) adults on pre-trial child support intervention.

One (1) juvenile is on electronically monitored home detention and eleven (11) juveniles attending CHANGE Academy.

Cost of Incarceration was once again discussed. Community Corrections has had supervision since July, 2018, a total of 81,966 days. A substantial about of dollars has been saved through the use of Community Corrections.

CHANGE Academy is doing well. There is some talk about operating during the summer but several questions need to be answered before that can happen.

Some discussion was had regarding Work Release. A request to approve the Revised Budget Summary which needs to be filed with the Department of Corrections today. Motion made by Tom Drzewiecki and seconded by Steve Teders. Motion passed.
