FINANCIAL SUMMARY:

FINANCIAL REQUESTS:

Kellie Knauer requested an additional appropriation for the CHANGE Academy of \$2,479.00 to replace the student reach in refrigerator.

Kellie also requested a transfer of Probation Funds of \$249.62 from the State Grant to purchase a laptop computer for the Probation Department.

Both of these requests were voted on together, Mayor Yoder moved that the requests should be granted; Judge Brown seconded. Motion passed.

OFFENDER PLACEMENT:

There are thirty-two (32) adult offenders on electronically monitored home detention. One (1) is on CTP; one (1) is on SCAM and ten (10) are on the pre-trial compliance program; four (4) on the pre-child support intervention program.

There are eleven (11) juveniles attending the CHANGE Academy.

COST OF INCARCERATION:

A substantial amount has been saved by the County and Department of Corrections by having the Community Corrections in place.

CHANGE Academy:

A new Violation and Incentive Policy has been prepared. Kellie Knauer ask that the Board look this over and see if they are in agreement. Claramary Winebrenner motioned that the Policy should be approved, seconded by Steve Teders. Motion passed.

IDOC Grant Application and Budget and Performance Metrics Mid-Point Progress Report need to be approved by the Board. Claramary Winebrenner motioned to approve and the Application and the Mid- Point Progress report, second by Judge Brown
