FINANCIAL SUMMARY:

OFFENDER PLACEMENT:

There are currently seventy-seven (77) cases being screened for placement. There are twenty-five (25) adults on monitored home detention, one (1) on CTP. There are ninety-five (95) adults on the community service program and ten (10) adults on the pre-trial compliance program. One (1) on the pre-trial child support intervention program and six (6) on the pre-trial veterans treatment court compliance program.

There are fourteen (14) juveniles at the CHANGE Academy.

COST OF INCARCERATION:

DeKalb County and the Department of Corrections have experienced a substantial savings since the Community Corrections has been in progress.

BUILDING UPDATE:

Progress continues on the building. More of the work is now being done on the inside.

SRS - Supervised Release System:

This program replaced the informer and was implemented on March 1, 2019.

CHANGE ACADEMY:

As stated earlier, there are 14 juveniles attending the CHANGE Academy.

IDOC GRANT APPLICATIONS:

FY20 Community Corrections - Adult IDOC Grant Application and Budget were presented and discussed. Motion made by Judge Brown to approve the same. Seconded by Judge Grimm, Motion passed.

FY20 Probation - Adult IDOC Grant Application and Budge were presented and discussion held. Motion made by Judge Grimm to approve the same. Seconded by Judge Brown. Motion passed.

Collaboration Plan - Version 1 and 2 - A motion by Judge Grimm and Seconded by Claramary Winebrenner to accept the plan and submitted both versions, explanation as to why signatures are not attached at this time. Motion passed.
