# MATTER OF REZONING:

Don Kaufman made a motion to approve the rezoning petition number 12-12 for Ronald K. Weller, DCC 36, UDO No. 11, "That the C3. General Commercial, classification of the Zoning Ordinance for the development through zoning of the territory within the jurisdiction of the DeKalb County Plan Commission be extended to include the following real estate in DeKalb County, Indiana, which is presently classified by said ordinance as R2, Medium Density Residential", part of the Northeast quarter of the Southeast quarter of Section 17, Township 34 North, range 13 East, Randall Deetz second and all approved.

Randall Deetz made a motion to approve the rezoning petition number 12-10 for Gary L.
