APPROVAL OF MINUTES OF LAST MEETING:

Tom Drezwicki made a motion to approve the minutes of last meeting. Seconded by Mark Olivero. Motion passed.

REPORT OF OFFICERS:

Kevin Likes state the new director will start April 11. He also stated that the employees at Community Corrections have stepped up and gone beyond their duties to see that Community Corrections has kept business as usual. He also believes that these employees are deserving of additional compensation. No further discussion at this time.

FINANCIAL SUMMARY:

There were two (2) transfer of funds requested.

\$620.00 from Travel/Training/Education to Insurance, to cover the remaining balance on the auto insurance premium for 2022.

\$31,305.72 from Residential Services Facilitator to the following:

\$13,500 to four (4) Residential Services Facilitators positions  
\$11,400 to three (3) Residential Services Supervisor positions  
\$2,500 to overtime  
\$3,905.72 to PERF/Insurance/Social Security

Motion was made by the Sheriff to approve the transfers. Seconded by Tom Drezwicki. Motion passed.

Advisory Board Chairman to approve Incite User Agreement for new Executive Director, Michelle Fosnaugh. Kevin Likes signed the Agreement, no other action was needed on this matter.

Michael Lapham explained that Community Corrections and the Probation Department would like to merge Redwood Toxicology account to get better pricing. Motion was made by Judge Squiller to combine the two (2) entities for the purpose of better pricing. Seconded by Judge Grimm. Motion passed.

Michael also explained CAM bracelet pros/cons. At the present time, the cost of a monitor is \$3.80 to Community Corrections, which they charge participants \$12:00. The price would go up if the new system was to be implemented.

#### CHANGE ACADEMY:

At the present time there are 17 participants enrolled with 1 awaiting intake.

DeKalb Central has 8 from the high school, and 2 from middle school

DeKalb Eastern has 4 from the high school and 2 from the junior high

Garrett-Keyser-Butler has 1 from the high school

#### COST OF INCARCERATION:

Community Corrections is having a good impact on inmate numbers for the DeKalb County Jail and the Department of Corrections.

#### INTENT TO PLAN AND IMPLEMENT CERTIFIED PRETRIAL SERVICES:

Agencies must certify pretrial programs to continue to be eligible for funding and funding may be transitioned from IDOC to Office of Court Services for Pretrial.

Letter was prepared for December 10, 2021 meeting but has not been signed or sent.
