

**AMENDED ORDINANCE NO. 2021-R-2**  
**DEKALB COUNTY CODE SECTION 28-9-9**  
**DEKALB COUNTY COMMISSIONERS**  
**AN ORDINANCE ESTABLISHING**  
**A RESTRICTED FUND FOR THE PURCHASE AND**  
**ADMINISTRATION OF VACCINES**

**WHEREAS**, the DeKalb County Health Department (“Health Department”) has been charged with responsibility to accept vaccines and related equipment, lease space to administer vaccines, and to secure persons to assist in administering the Vaccines, and actually injecting the Vaccines to the public; and,

**WHEREAS**, the Health Department has considerable expenses related to the related costs; and,

**WHEREAS**, a number of persons and entities have offered to donate funds to assist the Health Department in inoculating persons and in helping the orderly gathering of vaccine recipients; and,

**WHEREAS**, the DeKalb County Commissioners approved and adopted Ordinance No. 2021-R-2, DeKalb County Code Section 28-9-9 in three (3) readings on February 8, 2021; and,

**WHEREAS**, said Ordinance No. 2021-R-2, DeKalb County Code Section 28-9-9, included wording that narrowed the scope of the applicability of said Ordinance beyond what the DeKalb County Commissioners intended; and

**WHEREAS**, this Amended Ordinance No. 2021-R-2, DeKalb County Code Section 28-9-9 replaces in its entirety the Ordinance passed on three (3) readings on February 8, 2021, and declares that this Ordinance replaces that February 8, 2021 Ordinance in its entirety with this Amended Ordinance; and,

**WHEREAS**, there is no constitutional or statutory provision requiring a specific manner for establishing a donation fund for voluntary contributions for and on behalf of the Health Department, but the County Commissioners as the County Executive are empowered under that legislation commonly referred to as “Home Rule” to establish one or more new funds for a particular purpose or function, pursuant to Indiana Code 36-1-3-6(b) and (c) in connection with Indiana Code 36-1-3.

**NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE DEKALB COUNTY COMMISSIONERS OF DEKALB COUNTY, INDIANA THAT:**

- Section 1. There is hereby established a restricted donation fund for use by the Health Department in accepting vaccines and related equipment, leasing space for the administration of a program to administer vaccines to the public, and to secure persons to assist in administering the inoculations of those vaccines, and actually injecting the vaccines to the public.
- Section 2. Any person (individuals, groups, or business entities) may contribute money to fund this account for the restricted purposes set forth in Section 1. To assist with the ease of administration of this fund, only money contributions by way of cash, check, or money order will be accepted, and no contributions of materials or labor shall be acceptable under this Ordinance.
- Section 3. The County reserves the right to cut off contributions for this fund temporarily if the Commissioners deem that there are sufficient funds in the restricted account for the foreseeable future.
- Section 4. The Commissioners may repeal this Ordinance if the Commissioners determine that there is no longer a need for said funding, but any monies remaining in the fund must be utilized for the purposes for which the fund was established until the fund is depleted, and remaining funds shall revert to other donation funds, if any, that have an emphasis on health of County citizens. If there are no such funds, any remaining funds shall revert to such fund as determined by the DeKalb County Council that benefits County citizens.
- Section 5. Although current Section 170(c)(1) of the Internal Revenue Code permits tax deductible contributions to governmental units, including counties, for such public purposes, the County cannot confirm that contributions are tax deductible because the County has not sought a letter ruling from the Internal Revenue Service. However, the County has requested from the Internal Revenue Service a "governmental information letter" describing the government entity exemption from federal income tax, citing applicable Internal Revenue Code sections pertaining to deductible contributions and income exclusion, which letter will be made available through the County Auditor's office upon request.
- Section 6. Effective Date: This Ordinance becomes effective after passage of the third reading as adopted by the DeKalb County Commissioners and the publication of this Ordinance thereafter as required by law.
- Section 7. Ordinance Codified: This DeKalb County Ordinance Number 2021-R-2 is passed and adopted on all three readings and shall be codified in the DeKalb County Code as DeKalb County Code 28-9-9, and properly indexed in the Code.

Section 8. This Amended Ordinance No. 2021-R-2, DeKalb County Code Section 28-9-9, completely replaces the prior Ordinance replacing it in its entirety and assigning to this Ordinance the original Ordinance No. and DeKalb County Code number.


READ AND PASSED ON SECOND READING: Monday, March 8, 2021.


READ AND PASSED ON THIRD READING: Monday, March 8, 2021.


