**BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COUNTY  
OF DEKALB, STATE OF INDIANA, THAT THE UNIFIED DEVELOPMENT  
ORDINANCE OF DEKALB COUNTY, INDIANA AND MAPS PERTINENT  
THERE TO ARE AMENDED AS FOLLOWS:**

That the A4, Agricultural Business, classification of the Zoning Ordinance for the development through zoning of the territory within the jurisdiction of the DeKalb County Plan Commission be extended to include the following real estate in DeKalb County, Indiana, which is presently classified by said ordinance as A2, Agricultural.

The tract of land to be considered is as follows: Byler Acres, Section 1, Lot #1, Jackson Township, Section 16, DeKalb County, Indiana, located at 5858 County Road 35, containing 27.66 acres, more or less.




This ordinance shall take effect on the date of its passage and approval by the County Commissioners of DeKalb County Indiana.


