RESOLUTION NUMBER 152302 RESOLUTION OF THE TOWN OF ST. JOE, INDIANA

AUDITOR DEKALB COUNTY

WHEREAS, The DeKalb County Commissioners have adopted Resolution No. 2015-R-01; and

WHEREAS, said Resolution provides for terms and conditions by which the DeKalb County Commissioners would transfer certain tax delinquent properties to the City or Town for purposes of the Blight Elimination Grant project pursuant to the County's authority under IC 6-1.1-24-6.2; and

WHEREAS, the DeKalb County Commissioners have proposed to transfer the following property or properties to the Town of St. Joe, to-wit:

Herein incorporate the description of the property annexed hereto as Exhibit A

PROVIDED, the Town has twenty (20) days within to accept said transfers.

NOW, THEREFORE, the Town of St. Joe hereby accepts the transfer of said property or properties shown on annexed Exhibit A, with intentions of the County waiving the tax delinquencies subject to County conditions.

FURHTER, the Town acknowledges and accepts the terms and conditions set forth in DeKalb County Commissioners' Resolution No. 2015-R-01.

FURTHER, the Town understands that if mortgages or judgments or liens or other encumbrances on said property are not able to be cleared or do not come within the Grant terms for the Blight Elimination project, or for any other reason said property is not fixed up, including demolishing or repurposing, or completed as a Blight Elimination Grant property, then the Town shall transfer said property back to the County.

AND, further the Town shall notify adjoining property owners of each tract in accordance with IC 6-1.1-24-6.8 to see if they have any interest in acquiring the property, directly from the County Executive, and if, said adjoining property owners expresses such an interest within twenty (20) days of receiving notice the County Commissioners shall have the right to transfer said property to said adjoining land owner.

This resolution will be passed and adopted by the Town Board of the Town of St. Joe, Indiana on the 23rd of February, 2015.


