MATTER OF MINUTES:

MATTER OF NEW BUSINESS - 1782 LEVY NOTICE FOR 2013:

Bonnie Emerson of the Auditor's Office presented the 1782 Levy Notice for 2013 from the Department of Local Government Finance (DLGF) and its effect on cuts on the 2013 budget.

Robert Wilder made a motion to authorize Alan Middleton, President of the County Council, to write a letter to the department heads for a reduction of 10% of the 2013 budget to be presented to the Council at their March 4, 2013 meeting with a reminder to them of the hiring freeze, William VanWye second and all approved. They are to give this to the Auditor by February 27, 2013 so he can send this information to them before their meeting.

MATTER OF ADDITIONALS:

Ann Williams, Extension Educator HHS & CED, is asking for a correction in Joyce Doty's salary, she had figured it incorrectly. Janet Ordway made a motion to approve the \$300 from County General (1001) which will make the correction in Joyce Doty's salary (11203), Eldonna King second and all approved.

From Certified Shares (1110) \$1,020.88 to Deputy Prosecutor Kelly Morris (11256) to correct her salary in both the Prosecutors Office and the Title IV-D Office. Eldonna King made a motion to approve this additional, Larry Moughler second and all approved.

Robert Wilder made a motion to approve the use of \$1,278,230.00 for the Certified Shares Appropriation to fund the 2013 Certified Shares Budget, Janet Ordway second and all approved.

Cumulative Bridge (1135) in the amount of \$355,000 to replace Bridge #31 on CR 9 north of CR 68 over Black Creek (35440); Robert Wilder made a motion to approve, Larry Moughler second and all approved.

Cumulative Capital (1138) in the amount of \$42,235 to be used to pay for leased Xerox Copy Machines, Court House Copy Machines (44400); Janet Ordway made a motion to approve, Eldonna King second and all approved.
