Janet Ordway made a motion to approve the Minutes of April 4, 2011, Larry Moughler second and all approved.


## MATTER OF LETTER TO MICHAEL CALES, INDOT:

William Vanwye made a motion to adjourn, Alan Middleton second and all approved.






