# **MATTER OF MINUTES:**

Janet Ordway made a motion to approve Minutes of June 7, 2010, Don VanWye second and all approved.

#### MATTER OF ADDITIONALS:

Commissioners (19): From County General an additional appropriation of \$4,000 to NE IN Mental Health (34090) due to the increase in the Northeastern Indiana Mental Health monthly claim that the State requires DeKalb County to honor. Don VanWye made a motion to approve, Robert Wilder second and all approved.

Jail (23): From County General an additional appropriation of \$74,289.73 for the Electric Bill 0100-23-3351 at the Jail for the remainder of 2010. Alan Middleton made a motion to approve \$7,500 and Table \$66,789.73 until Ben Smaltz can do some further research, Keith Crow second and all approved.

Superior Court (26): From County General an additional appropriation of \$10,500 for fund 100.32780.000.026 for a five day jury trial scheduled in July. Janet Ordway made a motion to approve, Keith Crow second and all approved.

Extension Office (12): From Cumulative Capital Development (253) Non-Budgeted Expenditures (50000) in the amount of \$3,760 for Computer Equipment (44420). Keith Crow made a motion to approve, Larry Moughler second and all approved.

Information Systems Department (18): From Cumulative Capital Development (253) Non-Budgeted Expenditures (50000) in the amount of \$30,000 for Computer Equipment (44420). Keith Crow made a motion to approve, Larry Moughler second and all approved.

# **MATTER OF TRANSFERS:**

Highway (200): From snow removal equipment repair (76-34370) to grader blades (76-22830) in the amount of \$5,000 to offset price increases for blades that need to be replaced from use during winter and spring months. Robert Wilder made a motion to approve, Don VanWye second and all approved.

#### MATTER OF EMPLOYEE REPLACEMENTS:

Alan Middleton made a motion to replace the two part-time positions in the Plan and Building Department that are vacant with an inspector (field position) for 20 hours/wk at \$15/hr. and the office staff for 20 hours/wk at \$12/hr., Keith Crow second and all approved.

Keith Crow made a motion to approve the request from the DeKalb Soil and Water Conservation District to replace the technician position, Robert Wilder second and all approved.

Robert Wilder made a motion to approve the request from the Highway Department to replace a retiree, Don VanWye second and all approved.

Alan Middleton made a motion to approve the request from the DeKalb County Probation Department to fill the position for their support staff, Janet Ordway second and all approved.

#### MATTER OF OLD BUSINESS:

Jim McCanna discussed the \$7,500,000 for the new Central Dispatch Center, the Bonding Process and the proposed time line. Ben Smaltz discussed a leasing process through a vendor and bidding process.

Budget reviews will be August 18<sup>th</sup> and 19<sup>th</sup>. Council meeting in September will be the 13<sup>th</sup> with non-binding reviews, budget reviews and budget cuts on the 14<sup>th</sup> and 15<sup>th</sup> from 8:30 AM to 4:00 PM. ON August 2, 2010 will be the first review of Township Budgets. Points to review: vote centers and Council Budget.
