MATTER OF ADDITIONALS:

County General (100): Sheriff (05) overtime (11050) \$15,000.00 is needed due to the increase of arrests and three patrol units off the schedule (1 unit at the academy for 15 weeks, 1 unit to be hired and one at K-9 training) has caused a drain on the overtime budget. Keith Crow made a motion to approve this additional, Alan Middleton second and all approved.

Levy Excess (137): Non-budgeted Expenditures (50000) in the amount of \$41,316.74; with the \$4,231.63 that is left in the Children's Psychiatric Residential Treatment Services Fund and this additional, we will be able to pay all of the outstanding bills from 2008. Janet Ordway made a motion to approve this additional, Larry Moughler second and all approved.

Cumulative Capital Development (253): Non-budgeted expenditures (50000) in the amount of \$46,670 to purchase IP Phone System Handsets for DeKalb County Departments participating in the IP Telephony telephone system up-grade.
