MATTER OF ADDITIONALS:

Clint Knauer requested additional funds of \$11,800 for Code Enforcement Technician Plan Commission Account # 0100.1075030003013 (part time payroll), Plan Commission recommendation and job description paperwork provided. The Commissioners were asked if they were in favor of the part time position split for Lonnie Lanning between Plan Commission and Building Inspector, they all indicated they do.
