## **COUNCIL MINUTES - FEBRUARY 7, 2005**

#### MATTER OF ADDITIONAL APPROPRIATION

Assessor Dottie Leins explained her request for additional appropriations of \$20,000 in reassessment monies for the new construction line item. The contract for evaluation of new construction calls of 600 parcels at \$24,000 which has already been budgeted, but any additional assessments will cost \$40 per parcel. Dottie feels that the additional \$20,000 will be sufficient to pay for the additional parcels for the remainder of 2005. A motion by Keith Crow to approve the additional \$20,000 for reassessment was seconded by Janet Ordway and carried with 6 votes. Councilman Wilder cast the only nay vote.

#### MATTER OF HEIDTMAN STEEL

At the January meeting representatives of Heidtman Steel Company presented a request to amend an abatement application. A new SB1 was submitted with changes in the legal descriptions and slight changes in the assessed values reflecting the land adjacent to the plant already in use, but in a different direction from the first plan. The change allows for purchase of a somewhat larger parcel of land, which will then allow for a bigger building to house a somewhat larger assembly line, thus increasing the assessed value and allowing for more jobs.

A five-minute recess was allowed for the abatement committee to discuss the amended SB1. Following the recess the committee gave a favorable recommendation for the abatement.

A motion by David Yarde to accept the amended Statement of Benefits was seconded by Don VanWye and carried.

### MATTER OF VETERAN SERVICE OFFICER

The commissioners introduced Brian Lamm the newly appointed veteran service officer. Brian spoke briefly to the council explaining his qualifications and background.

## MATTER OF LOCAL OPTION HIGHWAY USE TAX - LOHUT

Councilman Smaltz opened the hearing at the advertised time and asked Commissioner Ort to introduce LOHUT, the subject for discussion. Council members were in receipt of an information packet provided by highway superintendent Patton, which outlined the decline of funding in both motor vehicle and local road and street areas. President Ort then explained that over the past 5 years highway funding from the state has been in sharp decline. Numerous highway projects and normal maintenance have been so curtailed that in several instances safety has become an issue. There is very little money to barely maintain roads by filling potholes let alone to resurface current roads or upgrade gravel road. The majority of funding is spent to maintain gravel roads and purchase sand and salt for use in inclement weather. The cost of all materials has increased, and striping projects are expensive, but extremely necessary for highway safety.

Discussion followed during which time councilman Yard and Wilder stated that they were not in favor of any sort of new tax.

Councilman Smaltz then opened the meeting for public comment.

Elbert Evans of Evans Trucking Company in Butler denied licensing any of his 100 trucks or 300 trailers outside of Indiana. He stated that he has never requested a tax abatement of any kind, but just wishes to be allowed to make a living. He does not favor the tax.

Randall Deetz stated that he represents the Farm Bureau and feels that road growth has encouraged rural development which has increased traffic on the county roads. Mr. Deetz does not feel the wheel tax would be fair to farmers who use certain equipment during only part of the year.

Auburn City Councilman Mike Walters understands that the county must pay for growth, however, he feels that amending the CEDIT plan for highway funding is a far better use than the \$80,000 which has previously been earmarked for helping to support a new county economic development commission.

Former director of NIRCC Eli Samaan has worked within the transportation area in Allen County for 30 years. Mr. Samaan stated that pending legislation will not aid the lack of funding for local highway departments. Federal and state monies will be dedicated to the state corridors. Newly acquired grants for County Roads 427 and 11A will require matching funds of \$200,000 and \$300,000 respectively. The county does not want to loose the grants by not being able to provide the matching funds.

Hamilton Town Manager Bob Howard encouraged the adoption of LOHUT as a method given by the state to help counties improve roads.

Commissioner Kaufman stated that he had been told that Mr. Evans' trucks were licensed outside the state of Indiana, and apologized to the group if his statement was not factual.

Councilman Wilder commented with regard to the use of EDIT monies in cities and towns, and wonders if support for the wheel tax is based on these units wishing not to use EDIT monies for roads.

Auburn councilman Walters stated the Auburn has used CEDIT monies for water and sewage treatment plans although he personally does not agree with the CEDIT tax to begin with.

The hearing was closed to public comment at this time.

A motion by Robert Wilder to continue the public hearing to the first county council meeting following the adjournment of the current state legislative session was seconded by Keith Crow and carried unanimously.

## MATTER OF ADDITIONAL APPROPRIATIONS AND TRANSFERS

A motion by Robert Wilder to approve all of the additional appropriations as requested for the health department (\$500 for operating supplies), Local Health Maintenance (\$6,569.50 for operating supplies) and \$23,747.66 in Tobacco Settlement Grant funds (\$4,000 for advertising, \$2,500 for travel, \$15,000 for vehicle purchase, \$1,000 for petroleum products, \$1,000 for liability insurance and \$247.66 for vehicle maintenance) was seconded by David Yarde and carried unanimously.

A motion by Keith Crow to approve an additional appropriation of \$5,000 in the User Fee Fund was seconded by Janet Ordway and carried.

A motion by Robert Wilder to approve the transfer of \$3,762.40 from officer equipment to police equipment was seconded by Don VanWye and carried.

A motion by Robert Wilder to approve the transfer of \$6,000 from software licensing to employee wages was seconded by David Yarde and carried unanimously following discussion of Janet Ordway's concern of consideration for the correct use of the monies.

A motion by Keith Crow to transfer \$49.98 within the jail budget from laundry and janitorial to furniture and fixtures was seconded by Don VanWye and carried unanimously.

A motion by Keith Crow to transfer \$500 within the Sunny Meadows budget from laundry to furniture and fixtures was seconded by Larry Moughler and carried.

A motion by Keith Crow to transfer within the Reassessment budget \$89.25 from other services to furniture and fixtures and \$123.68 from office supplies to computer equipment for the union Township Assessor and \$451.92 from reassessment postage to furniture and fixtures was seconded by Janet Ordway and carried.
