DEKALB COUNTY ORDINANCE NO. 2020-R-10
DEKALB COUNTY CODE 9-1-2-14
ESTABLISHMENT OF YIELD ON BOGER AVENUE AT ITS
INTERSECTION WITH LUCILLE AVENUE

WHEREAS, the DeKalb County Highway Department has engaged the services of Northeast Indiana Regional Coordinating Council ("NIRCC") to study the intersection of Boger Avenue with Lucille Avenue to lessen confusion on the right-of-way at said intersection;

WHEREAS, Lucille Avenue is a north-south improved (paved) local roadway with adjacent residential and agricultural land uses, is approximately 1,045 feet long and extends south from County Road 40A until terminating approximately 450 feet south of its intersection with Boger Avenue;

WHEREAS, Boger Avenue is an east-west improved (pave) local roadway with adjacent residential land use and is approximately 350 feet long and extends east from County Road 35 to Lucille Avenue;

WHEREAS, NIRCC, based upon its study of said intersection and the desire to lessen confusion for traffic on both roads as a driver approaches the intersection, and has recommended that traffic on Boger Avenue must yield the right of way to any vehicle or pedestrian approaching its intersection with Lucille Avenue as the primary roadway so that there is no confusion regarding who should yield the right-of-way;

WHEREAS, as a result of the investigation and study by both the DeKalb County Highway Department and NIRCC, the DeKalb County Commissioners should cause a yield sign to be placed on Boger Avenue at its intersection with Lucille Avenue northeast of the City of Auburn, DeKalb County, Indiana.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE DEKALB COUNTY COMMISSIONERS OF DEKALB COUNTY, INDIANA THAT:

- Section 1. **YIELD SIGN FOR EAST BOUND TRAFFIC ON AVENUE AT ITS INTERSECTION WITH LUCILLE AVENUE**: For the benefit and safety of traffic traveling at the "T" intersection wherein Boger Avenue traffic must turn north or south onto Lucille Avenue, a yield sign shall be placed on Boger Avenue at its intersection with Lucille Avenue, in accordance with county road specifications for Yield Signs.
- Section 2. **YIELD SIGN VIOLATIONS**: Violators of this Ordinance may be charged by a traffic summons issued by any police officer having traffic enforcement jurisdiction in the area of the intersection of Boger Avenue and Lucille Avenue northeast of the City of Auburn, DeKalb County, Indiana.

- 2.1 The DeKalb County Prosecuting Attorney or any other entity with authority to prosecute violations of any traffic summons are authorized to prosecute any violation of this Ordinance.
- 2.2 Any Court of DeKalb County, Indiana, having general traffic jurisdiction shall be empowered to process such charges as violations of the law, similar to other traffic violations of the Indiana Code.
- 2.3 Any existing penalties for violations shall be applied to this Ordinance and be imposed for any such violations.

Section 3. **EFFECTIVE DATE:** This Ordinance shall become effective after passage of the third reading as adopted by the DeKalb County Commissioners and after the publication of this Ordinance thereafter as required by law.

Section 4. **ORDINANCE CODIFIED:** This DeKalb County Ordinance Number 2020-R-10 shall be codified in the DeKalb County Code as Section 9-1-2-14 and appropriately indexed in the DeKalb County Code.

Section 5. **PLACEMENT OF YIELD SIGN:** After the publication of this Ordinance is completed, the DeKalb County Highway Superintendent shall place a yield sign on Boger Avenue at its intersection with Lucille Avenue in accordance with this Ordinance.


READ AND PASSED SECOND READING: Tuesday, May 26, 2020.


