## ORDINANCE NO. 2020-R-24 DEKALB COUNTY CODE SECTION & - ラ-ラ-ス DEKALB COUNTY BOARD OF COMMISSIONERS AN ORDINANCE ACKNOWLEDGING THE CHANGE OF MEMBERS OF THE DEKALB COUNTY TOURISM COMMISSION

WHEREAS, by Ordinance No. 2020-R-16 dated August 3, 2020 ("Prior Ordinance"), the Dekalb County Board of Commissioners ("Commissioners") established the DeKalb County Tourism Commission (the "Tourism Commission");

WHEREAS, the initial members of the Tourism Commission were named on a list attached as Exhibit B to the Prior Ordinance;
