WHEREAS, John created his first ACD Festival poster in 1981, and it was so loved and appreciated that he was asked and then volunteered free of charge to create ACD Festival posters over thirty-six years; and only his battle with cancer lead to his ending this service with his last memorable post in 2017; and

WHEREAS, John impacted Auburn and classic car enthusiasts worldwide with his talent for bringing Auburn car history to life; and

WHEREAS, John touched the lives of all who knew and appreciated him.

**NOW, THEREFORE, BE IT RESOLVED**, that the DeKalb County Commissioners commemorate the life of John David Souder; and acknowledge that in his passing, our community has lost a faithful and valued servant; and express our gratitude and respect for his unselfish service.
