Community Corrections supervision since July 2010 (MEMS/SCRAM NOT included) total <u>162,090</u> days (ending July 31, 2023). It would have cost <u>\$6,078,375.00</u> to incarcerate those offenders in the County Jail, and <u>\$8,746,376.40</u> at the DOC. This does not include medical costs.
