SUBDIVISION PLAT DRAINAGE PLANS

MILL HILL PLAT (DVS ACREAGE) – 2822 COUNTY ROAD 56 (SOUTHEAST CORNER OF COUNTY ROAD 56 & COUNTY ROAD 27)

The Board reviewed the drainage plan for the Mill Hill Plat, located at 2822 County Road 56, on the southeast corner of County Road 56 and County Road 27, in the Northwest 1/4, Section 17, T33N, R13E, Jackson Township. This plat is for a one-lot minor subdivision, platted as 2.04 acres, 1.73 net acres. The plat is located within the watersheds of the John Cool Tile Drain No. 371-00-0 and the Cedar Creek Open Drain No. 470-00-0.

Angie Wallace of Compass Land Surveying presented the plat stating that the Millers wanted to plat the parcel for the construction of a single-family home. The Millers were applying for a Board of Zoning Appeals Standards Variance as the lot would be 1.73 net acres after the road right-of-way dedication in the plat. Mrs. Wallace stated there had been six borings producing two locations viable for support of a septic system, meeting the Health Department's septic requirements. Mrs. Wallace also explained that the wetlands on the property had been delineated and were on the plat as per the delineation.

The Board accepted the Surveyor's Drainage Report, which stated "In regards to the application for Mill Hill Plat, I approve for there exists adequate drainage for the proposed lot."

Mike Watson moved to approve the plat drawings dated January 10, 2024, as submitted by Angela D. Wallace, Land Surveyor for Compass Surveying with the Surveyor's recommendations, the motion was seconded by Bill Hartman, and the motion carried.

Note that member Jim Miller stepped out of the meeting during this plat review and stepped back in after.

SURVEYOR'S REPORT

Mr. Bell asked for the Surveyor's Report and the surveyor's staff provided the following information:

Mr. Lanning presented for Drainage Board signatures the applicant signed variance agreement for Metal X at 1203 Ensley Avenue, Auburn, Indiana for a fence and light poles for the *William Spangler Lateral 1 Tile Drain No. 189-001-0* and the *Eliza Werntz Tile Drain No. 69-00-0*. The variance had been approved by the Board at the January 4, 2024 meeting.

Mr. Lanning explained the Metal X Consent and Waiver petition for vacation of the upper end of the William Spangler Lateral 1 Tile Drain No. 189-001-0 also needed to be signed by a NIPSCO Representative as the vacation would affect their property on the south side of Auburn Drive. The Surveyor's Office had reached out to NIPSCO without receiving a response. Mrs. Lassiter had sent the information to ERI, the engineering firm representing Metal X informing them that they or Metal X needed to acquire the NIPSCO signature for the vacation to take place. Ms. Kruse stated to keep this petition on the office radar, that if NIPSCO did not sign then it should be handled through a public hearing process.

Mr. Lanning informed the Board that the Surveyor's field staff had attempted to locate the *John Bemenderfer Lateral 3 Spur 1 Tile Drain No. 49-03-1*, which was the more southerly located drain damaged by NIPSCO along Old US 27 during the installation of the Trine Gas Pipeline. However, there was so much water they were unable to dig. The field staff was going to call for locates on the east side of the road and would have the contractor dig up the tile, then the field inspectors would run the locator up the tile towards the pipeline and flag the tile for NIPSCO to come back out and

repair the damaged tile. In the meantime, the utility permit for Mercury Broadband was still on hold until the tile damages could be resolved with NIPSCO. Additionally, Mr. Lanning informed the Board that Mercury had changed their plans. Instead of installing the fiber on the east side of the road, they were now proposing to install the fiber on the west side of the road.

Mr. Lanning informed the Board that the phase two reconstruction of the *William Bickel Tile Drain No. 133-00-0* was moving along. 2300 feet of 24-inch tile was now in the ground. The contractor would be moving to the other side of the road. The contractor had not been on site this week due to the subfreezing weather but planned on working on the project next week with the warmer temperatures.

Mr. Lanning explained that the request for bids for the *John Ketcham Tile Drain No. 334-00-0* had been sent out to ten contractors and published in The Star newspaper twice with a January 31, 2024, due date. Joe Gabet of ForeSight Consulting had reported that only three packets had been picked up. There was hope that since there was still some time left more contractors would pick up packets.

Mr. Lanning reported that Knott Excavating would be starting the demolition of the Auburn Hotel at the end of January and hoped to begin the reconstruction of the *Fred Groscup Tile Drain No. 352-00-0* in Garrett by the end of February or the beginning of March.

Mr. Lanning stated that he and Mrs. Lassiter had been looking at the General Drain fund to make sure there was adequate funding for this year's planned drain reconstructions, especially the *Levi O. Dennison Tile Drain No. 317-00-0*. There appeared to only be approximately \$450,000.00 available in the account. Mrs. Lassiter stated there were several drain reconstruction assessments still being collected, with the landowner having the statutory five years for payment. Mrs. Lassiter stated that she believed there was a section in the Drainage Code that would allow the Commissioners to a determined amount from the County's General Fund to the General Drain fund if it was so desired by all involved. Mrs. Lassiter reminded the Board that during the first public hearing for phase two reconstruction of the *William Bickel Tile Drain No. 133-00-0* a loan was given by the County Commissioners and Council to the General Drain fund to cover the cost of that project. The County Auditor is now pulling payments out of the General Drain fund to repay that loan. Mr. Watson stated that there was also approximately half of a million dollars in ARPA funds that could be used for reconstructions. Mr. Watson further explained that some of the original restrictions placed on the funds had been removed. At one point those restrictions would have limited the funds for the engineering of a drain reconstruction, but that was no longer the case.

Mr. Lanning and Mr. Crawford informed the Board there were some issues with the A. L. Ober Drain No. 24-00-0 that the Surveyor's Office was trying to decide how best to resolve.

Mr. Lanning explained that the *E.P. Griffin Tile Drain No.* 224-00-0 and the *Erwin Selke Tile Drain No.* 439-00-0 were both in bad shape flooding homes and roads. The *E.P. Griffin Drain* would need to be done in two phases with the lower end from *Cedar Creek Open Drain No.* 470-00-0 to County Road 19 being done first. The second phase on the upper end would require extensive engineering due to the drain being located under structures and through a swamp. Mr. Hartman stated the two-phase plan for the *E.P. Griffin Drain* sounded good to him.

Mr. Lanning and Mr. Crawford stated that the Wilderson drain system by IN 205 south and west of Garrett would need extensive reconstruction as it is flooding several roads.

Mr. Lanning and Mr. Crawford stated some small drains on the reconstruction list could be moved up in priority that could be done quickly and would not cost as much as the bigger drains on the list.

There being no further business or discussion, Mr. Bell thanked everyone for attending the meeting and declared the meeting adjourned at 8:56 a.m.
