Robert Krafft opened the meeting with prayer at 9:03 a.m.

MATTER OF MINUTES

David Yarde made a motion to approve minutes dated December 12, 2023. Rick Collins seconded.

MATTER OF REORGANIZATION

William VanWye nominated David Yarde as president, Amy Prosser seconded. Amy Demske nominated Rick Ring, there was no second to the nomination. Motion passed for David Yarde as President unanimously.

Robert Kraft nominated William VanWye for Vice President. Rick Ring seconded. Robert Krafft motioned to close nominations; Amy Prosser seconded to close nominations. Motion passed for William VanWye as Vice President unanimously.

Robert Krafft made a motion to retain Don Stuckey. William VanWye seconded and all approved.

MATTER OF ADDITIONAL APPROPRIATIONS

No Additionals were needed.

MATTER OF TRANSFERS

Rick Ring made a motion to approve the Sheriff transfer of \$1,972 from Operating Supplies (22130) to Purchase of Vehicles (44610) within the School Resource Officer Fund (9105). Rick Collins seconded and all approved.

MATTER OF 2023 YEAR-END TRANSFERS

Rick Ring made a motion to approve 2023 year-end transfers. Amy Demske seconded, and all approved. The list of transfers is attached to these minutes.

MATTER OF 2023 ENCUMBRANCES INTO 2024

Rick Ring made a motion to approve 2023 encumbrances into 2024. Amy Demske seconded the motion, and all approved.

MATTER OF FINANCIAL REPORT BY FUND

The Council certified that they have received and reviewed the December 2023 Financial Report by Fund.

Regular Council Meeting paused for a Public Hearing as advertised.

MATTER OF PUBLIC HEARING FOR ORDINANCE 2024-OCC-1 | MODIFYING LOCAL INCOME TAX RATES FOR DEKALB COUNTY

Public Hearing opened at 9:30

Auditor Sleeper explained the reason for this Ordinance for the State. Rick Ring pointed out a few points including that the PTR rate is 0.5% which is uncommon among the surrounding Counties, such as Lagrange .15%, Steuben .29%, Noble .25%, and Whitley .03%. He stated we are directing more of our income tax relief to the residential property, not businesses or agriculture; if the Council had not directed it in this manner the property taxes in DeKalb County would be increased.

David Yarde asked for any public comment for or against the Ordinance, there was no patron in attendance that wanted to speak.

Robert Krafft asked if all the LIT funds were committed at this time, which would mean they overall tax rate could not be reduced.

Public Hearing closed at 9:42 a.m.

Rick Ring made a motion to approve Ordinance 2024-OCC-1 on FIRST Reading. Robert Krafft seconded and all approved.

Rick Collins made a motion to suspend the rules and vote on 2nd & 3rd Readings of Ordinance 2024-OCC-1. Robert Krafft seconded and all approved.

William VanWye made a motion to approve Ordinance 2024-OCC-1 on SECOND & THIRD Readings. Amy Demske seconded and all approved.

MATTER OF PTABOA BOARD APPOINTMENTS FOR 2024

For the PTABOA Board, Assessor Stonebraker has done all she could to find qualified candidates who are Democrats.

Rick Ring motioned to waive the political party requirement. Robert Krafft seconded, and all approved.

Amy Prosser motioned to waive the level 2 or 3 certification due to the lack of qualified individuals holding the certification. Rick Collins seconded, and all approved.

Amy Demske motioned to Re-Appoint Kyle Branscum and Marcia Seevers for the 2024 Board. Robert Krafft seconded and all approved.

MATTER OF RESOLUTION 2024-RCC-1 | PRELIMINARY (DECLARATORY)
RESOLUTION FOR THE CREATION OF AN ECONOMIC REVITALIZATION AREA

William VanWye made a motion to approve Resolution 2024-RCC-1 as described above. Rick Ring seconded and the motion passed (6,1) with Prosser voting against.

MATTER OF BOARD OF FINANCE RESULTS | TREASURER WILCOX

Treasurer Wilcox handed out the Annual Board of Finance Report. The calendar year of 2023 ended with \$65,583,211.84 in all accounts. Interest income earned in 2023 resulted in \$3,572,311.28, in 2022 the amount is \$872,031.71, and in 2021 the amount is \$71,262.72. Next Treasurer Wilcox went the Summary of Collections for 2023 that showed a total of \$253,088,038 of total cash flow through the Treasurers' Office. Most of the property tax payments came by way of walk-ins, mail or dropbox at 52.0%, Mortgage Escrow at 27.4%, Electronic Payments at 15.00%, Partner Bank Locations at 1.10%, and Misc. Collections such as TRECs, AFCS at 0.5%. The delinquency rate for 2023 was at 7.02%, up from 6.97% for 2022, but still down from 7.30% in 2020. That represents about \$2.69 million dollars in delinquencies. There were 70 tax sale properties in 2023, compared to 64 in 2022 and 130 in 2021. Finally, Ms. Wilcox went over 2023 Achievements and 2024 Goals. Accomplishments included: New online payment portal, Invoice Cloud went live February 1, 2023, earned more interest on County money in 2023 than in the last 10 years combined by being diligent about the earning strategy, worked with Beacon Schneider to get real estate, mobile home & personal property searches combined, successfully transitioned the in-person tax sale to online only, and First Deputy completed 2 additional courses in the NaCo Professional Development Leadership Program-Leading in Analytics and Leading on Purpose. Goals for 2024 are: work with Auditor's office to complete the cleanup of remaining parcels with unknown owners and unknown locations, decrease the delinquency rate as well as postage costs for county by utilizing Invoice Cloud's marketing strategies to promote paperless billing, recurring & automatic payments, Continue to be diligent about earning interest on county money with a goal to earn \$2.0 million in interest for the year, even in environment of

declining interest rates, Digitize all bankruptcy files to eliminate paper storage of bulky records, Work with CSB to enable positive pay on ACH transactions, streamline department "green" receipt process, cross train staff on settlement process, and Transition Treasurer's office responsibilities to the newly elected treasurer to assure seamless changeover.

MATTER OF COMMISSIONERS-COUNCIL DISCUSSION

President Hartman stated that Mike Watson can add anything to this discussion, but wanted to address the Sunny Meadows situation and explained some of the upgrades that have been done and will be completed this coming year. Bill also addressed the New Highway build, stating it is progressing but there have been some slow times due to the quantity of workers. Hartman then gave an overview of the Maintenance Employee that was added to primarily cover Sunny Meadows, DCCC & Central Communications. He then discussed the Weights & Measures truck and how the Commissioners want to get him a van and designate the prior truck as the maintenance vehicle. The Building Inspector Truck was also discussed as it needs to be traded in due to a known transmission issue.

MATTER OF 2024 SHERIFF SALARY CONTRACT

The Sheriff shall be paid a fixed amount of compensation in place of fee compensation in accordance with I.C. 36-2-13-2.8 in the amount of 70% of the full time Prosecutor's salary which calculates to \$124,718 for the calendar year 2024. The Commissioners approved the contract on December 18, 2023 contingent on DeKalb County Council's approval.

Rick Collins made a motion to approve the 2024 Sheriff's Salary Contract. William VanWye seconded and all approved.

MATTER OF COMMISSARY REPORT FOR JULY 1 TO DECEMBER 31, 2023

William VanWye made a motion to acknowledge receipt of receiving the Commissary Report from the Sheriff. Amy Demske seconded and all approved.

MATTER OF RECEIPT OF ANNUAL CORONERS REPORT

William VanWye made a motion to acknowledge receipt of receiving the Annual Coroner's Report. Amy Demske seconded and all approved.

MATTER OF TRANSFER FROM COUNTY GENERAL TO RAINY DAY FUND

Robert Krafft made a motion to approve Resolution 2024-RCC-2, A Resolution Transferring Funds from the County General Fund to the Rainy-Day Fund in the amount of \$542,859 (the last year to move 15%). Amy Demske seconded, and all approved.
