 - c. The Probation Department has worked toward using EMHD as an alternative to detention. The fee for this level of supervision needs added to the DCCC fee schedule. **Attached-VOTE**.
- D. <u>Cost of Incarceration</u>: The DeKalb County Jail estimates the cost to house an inmate for one day is \$37.50. The DOC estimate is \$53.96 per day. Community Corrections supervision since July 2010 (MEMS/SCRAM NOT included) total <u>175,267</u> days (ending February 29, 2024). It would have cost <u>\$6,572,512.50</u> to incarcerate those offenders in the County Jail, and <u>\$9,457,407.32</u> at the DOC. This does not include medical costs.
- E. IDOC Adult Grant 2025:

The mission of DeKalb County Community Corrections is to increase public safety by reducing recidivism and encouraging participants to be productive community members through cost savings and enhanced coordination of local adult and juvenile justice systems.
