APPROVAL OF AUGUST MINUTES:

A motion was made to amend the minutes of the previous meeting as follows: "Work Release was discussed. Kellie stated that the first amount to be awarded in the spring was \$950,000 and that has since been awarded to other agencies". Remainder of paragraph one (1) on page 2 is deleted. Motion made by Judge Brown and seconded by Steve Smith. Motion passed.

REPORT OF OFFICERS:

Tim Baker stated that there has been an Executive Committee established, Donna King; Steve Teders and Tim Baker. They will be talking with Auditor, Jan Bauman, to see what their "range of motion" might be. He will report back on their findings.

Mark Olivero stated that the Public Defender's office has set up a meeting with the State regarding "Recovery Works" on November 17, 2016 at the Annex building.

NEW BUSINESS:

Offender placement on Community Corrections supervision is currently 34 adult offenders, 3 of which are on CPT. Twelve (12) juveniles are attending CHANGE Acadermy and there are 98 individuals on community service restitution program.

Dates for the upcoming year for meetings of the Advisory Board were presented:

January 13, 2017; March 10, 2017; May 12, 2017; August 11, 2017; October 13, 2017 and December 15, 2017

Motion was made by Tom Drzewiecki, seconded by Judge Brown. Motion passed.

CHANGE Academy has a total of 13 participants and the program seems to be working very well.

Kellie requested transfers from FY2016 to help "clean up" negative balances. Motion made by Claramary Winebrenner that this be done, seconded by Judge Brown. Motion approved.

Kellie also requested that a transfer from FY2017 to accommodate additional training expenses be done. Motion made by Claramary Winebrenner to do this, second by Judge Brown. Motion approved.

Finally, Kellie requested from FY2017 an appropriation to purchase a new vehicle. The 2008 Jeep Liberty would be traded in at a trade in value of \$4,500. The new purchase would be around \$21,640. Motion made by Tom Drzewiecki to appropriate funds for the purchase, seconded by Judge Brown. Motion approved.

Kellie stated that Judge Wallace and several others on the Work Release Committee met with the DeKalb County Commissioners on October 10th to discuss the purchase of property for property for the new Jail and Work Release facility. The Commissioners are meeting on Octobre 17, 2016 regarding possible land sites.
