MATTER OF GRANT AGREEMENT AND POLICY TO OVERSEE THE DART PROGRAM

Director Duane Blankenship presented a policy for the Commissioners to consider adopting. It is to formalize the DART claims review and approval process. The County has lacked a policy, and State Board of Accounts would like for one to be adopted. Donald Grogg made a motion to approve the Policy for Oversight of DART Reimbursements as well as the Section 5311/5339 Grant Agreement for 2 new vehicles in 2021 in the amount of \$100,700. William Hartman seconded, and all approved. The grant agreement is EDS #A249-21-G200156, Project #3400765C, and is for CARES funding of a new low floor mini van and the replacement of a small transit vehicle.
