AN ORDINANCE AMENDING THE DEKALB COUNTY
2020 SALARY AND HOURLY WAGE ORDINANCE

WHEREAS, DeKalb County Council approved its budget for 2020 by passing the 2020 Salary and Hourly Wage Ordinance on September 30, 2019 and,

WHEREAS, the budget established by the County Council did not include salary, hourly and wage for individuals whose salary classification had not been established,
