

2020 Salary and Hourly Wage Ordinance

DeKalb County Council

Ordinance # 2019-OCC-9

The DeKalb County Council hereby establishes the following: Salary and Hourly Wage Ordinance to become effective for pay period 12/10/2019 - 12/23/2019 (paid on January 3, 2020) thru pay period 12/08/2020 - 12/21/2020 (paid on December 31, 2020).

IT IS FURTHER ORDAINED that all salaries and wages shall be paid bi-weekly (27 pays).

IT IS FURTHER ORDAINED that any employee hired after the date of this ordinance will have one pay period withheld for audit purposes.

Wherefore, be it ORDAINED this 30th day of September, 2019, that employee will be paid no more than what is set forth in this ordinance unless amended.
