**Janet L. Ordway Surber Memorial**

**WHEREAS**, Janet L. Ordway Surber has been a true and faithful servant of the citizens of DeKalb County for many years, excelling in her commitments both as a public servant in political service, and as a contributing member of her community in community service; and

**WHEREAS**, Janet L. Ordway Surber served in government service for thirty-three (33) years, beginning as the Waterloo Clerk-Treasurer from 1983 to 1991; as the DeKalb County Treasurer from 1992 to 2000; and she also service sixteen (16) years on the DeKalb County Council from 2000 to 2016; and

**WHEREAS**, during Janet's time as Clerk-Treasurer in Waterloo, she was instrumental in starting the Waterloo Industrial Park; and

**WHEREAS**, in the area of community service, Janet served in the Waterloo United Methodist Church where she served her church in a number of capacities: Trustee, Finance Chairwoman, Sunday School Teacher for over fifty (50) years, and was a member of the choir; and

**WHEREAS**, Janet was the first woman to join and become a member of the Waterloo Lions Club, serving as Zone Chairwoman and District Chairwoman and was awarded the Melvin Jones Award from the Waterloo Lions Club; and

**WHEREAS**, Janet was a member of the Republican Women's Club, serving several years as President, Precinct Committee Woman, and was honored as the Woman of the Year; and

**WHEREAS**, Janet was likewise committed to her family, having married Jerry Ordway on June 16, 1956 who preceded her in death on October 23, 1976; and she married Kenneth Surber on December 14, 2015 in Waterloo, and he survives. She is also survived by a daughter, Jacqueline Evans of Waterloo, four (4) step-children, a son-in-law, and two (2) grandchildren, two (2) step-granddaughters, two (2) great-grandchildren, three (3) brothers-in-law, a sister-in-law, a special Aunt and many nieces and nephews. She was preceded in death by her parents, her first husband, a daughter Janine Riley, a sister Laura June Jordan, three (3) brothers-in-law and four (4) sisters in law.
